#### **MAJOR DUTIES:**

The I)rimary purpose of this position is: To Perform the duty as Customer Service Representative in the Customer Service Section for General Purpose and Special Purpose Vehicles. To perform periodic safety inspections; inspect general purpose, special purpose vehicles and equipment for quality assurance on repaired vehicles. Performs duties as Automotive Inspector for privately owned vehicles (POVs). Provides customer service for nlilitary and civilian personnel, provides fast and dependable service to the user; debriefs vehicle operator; performs incoming inspections n vehicles and equipment for the purpose of determining maintenance requirements; verifies vehicle malfunctions and performs a complete inspection using diagnostic test equipment when required. Determines if the vehicle malfunction is a result of suspected abuse, delayed/deferred and if the vehicle is due for scheduled inspections, using current computer program; initiates an AF Form 1823 or using the DPAS format. If the repair takes more than two hours to complete, opens up a work request; performs mechanical repair, if repair is under 2 hours. Verifies that the vehicles are IAW AFI -23-302 when turned in for maintenance; checks if vehicle or equipment is due for maintenance Ofl current computer program. Certifies for the completeness and accuracy of work done by other automotive mechanics for the purpose of Quality Assurance before the Vehicle is getting released to costumer. Performs mechanical inspections on privately owned vehicles (POV) which are of different foreign and domestic origin, various design and make. Inspects vehicles for compliance with AE Reg. 190-1 aiid German traffic laws (Strassenverkehrszulassungsordnung - STVZO). Checks frame and body, fuel tank and lines, tires and wheels, steering, hand aiid foot brakes, and the operation of all lightning and other electrical devices. Completes safety inspection records required for the registration of the vehicle, indicating all necessary data. Certifies inspection findings, rejects, or releases vehicles. In case of rejection, indicates found deficiencies on inspection record and reschedules vehicles for required post-inspection. Explains deficiencies detected to the vehicle owner and indicates repair work to be conducted. Certifies for completeness and accuracy of inspection and roadworthiness of vehicle. Prepares monthly report of vehicles inspected indicating the number of vehicles passed and failed, reasons for failure, organization of owner and vehicle data. Performs safety inspections; inspects special and general-purpose automotive vehicles and equipment turned in for repair, periodic maintenance, or technical order compliance; and conducts quality assurance on repaired vehicles. Performs visual inspections and operational tests. Using testing instruments and conducts test runs to determine safe mechanical operating condition and serviceability status to locate defects of parts or components; orto recommend vehicle disposition action. Upon completion of shop work, conducts quality assurance inspections including operational and road tests; where appropriate, to ascertain that specified work has been accomplished and repair work done meets established serviceability standards. Rejects vehicles/equipment not meeting the required technical adequacy of repairs and quality standards. Also inspects repair work in progress to assure that equipment is being repaired in accordance with pertinent requirement. Utilizes safety practices and procedures following established safety rules and regulations and maintains safe and clean work environment. Uses and assures proper fit of required safety equipment and clothing. Uses and maintains hand and power tools. Maintains records and documents actions. Complies with environmental directives pertaining to handling hazardous waste.
